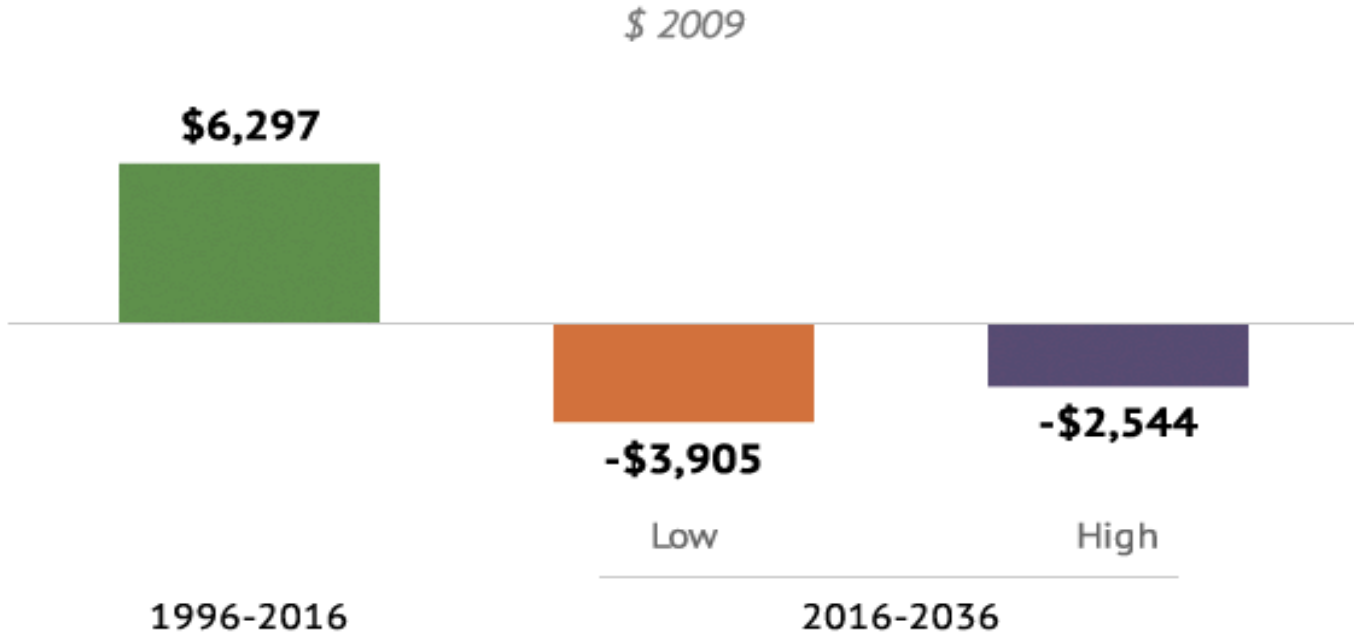

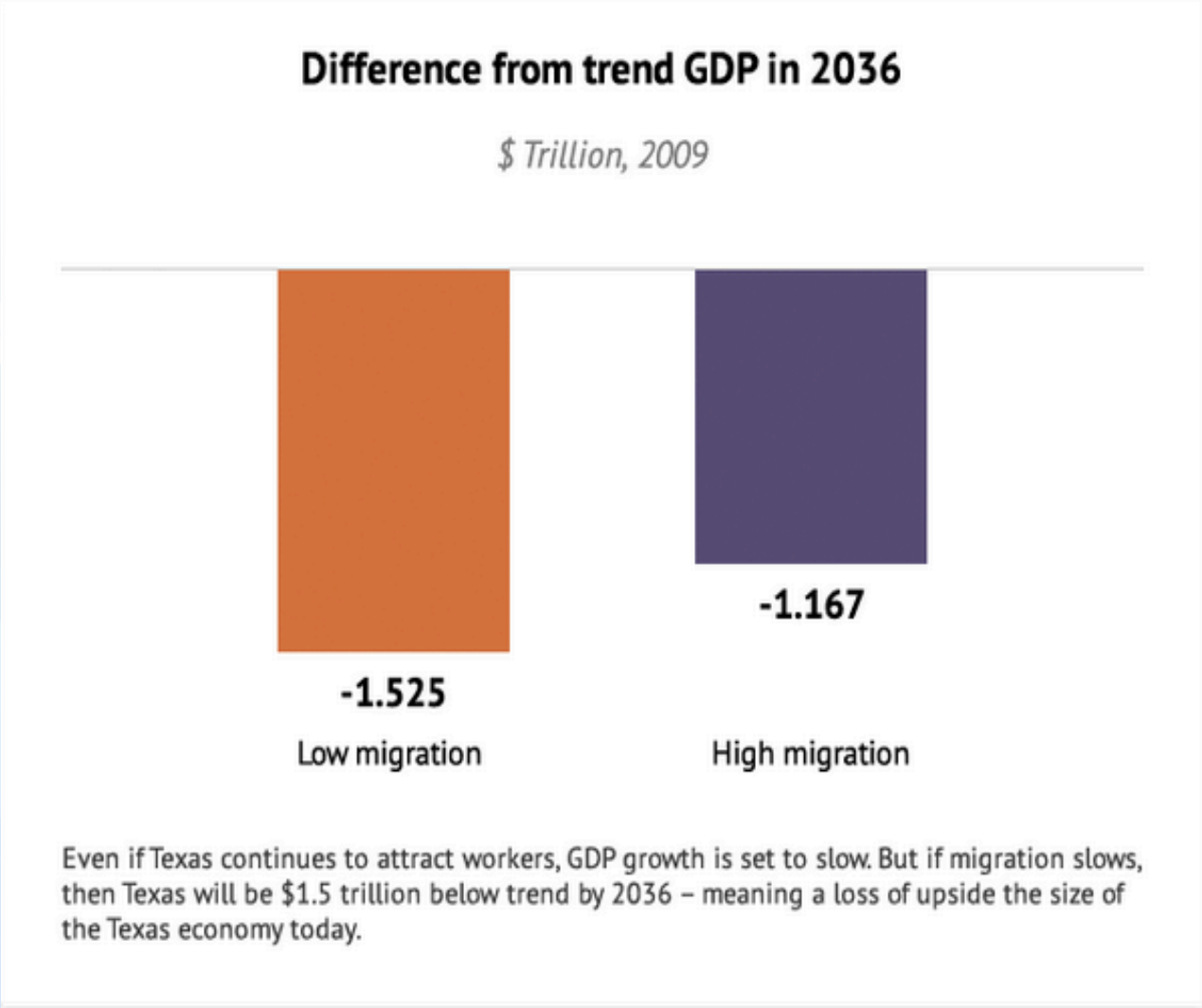
## Changes in real median household income, 1996-2036



Real median household income rose by \$6,300 over the past 20 years. Unless something changes, we risk giving back half of that by 2036.

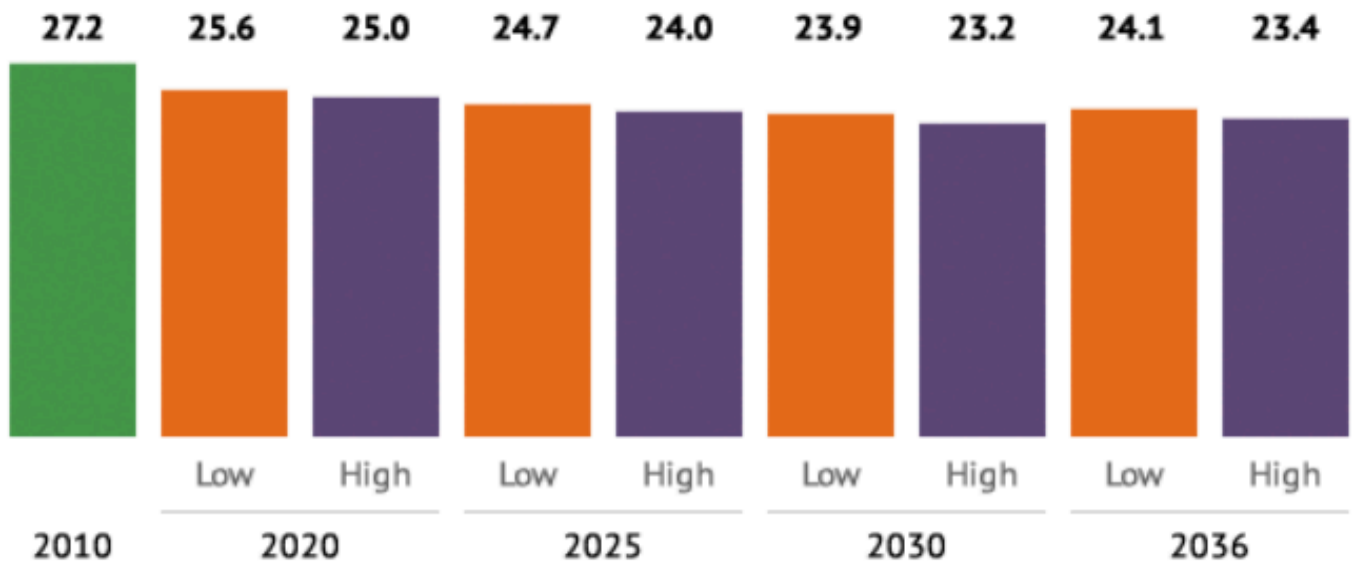
# Difference from trend GDP in 2036



# Decreasing % of population with more than a high school education

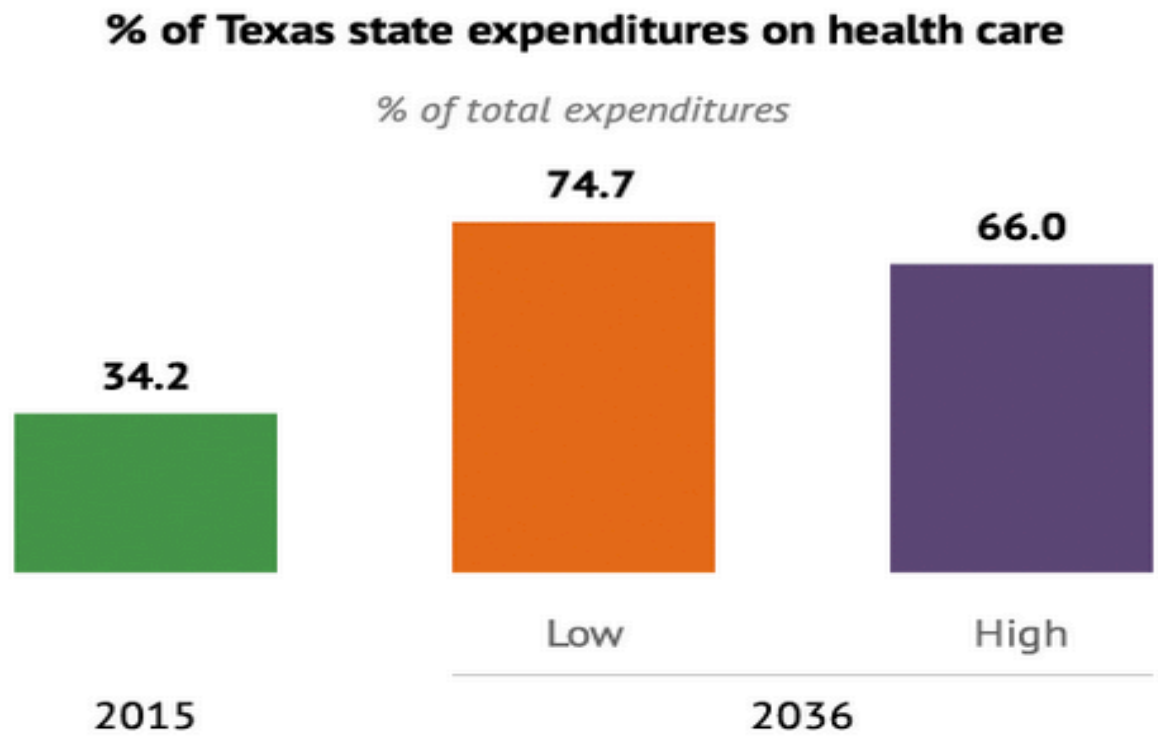
## Educational Attainment in Texas, 2010-2036

Educational attainment has steadily risen since 2000, but the expanding portion of our population with the lowest educational attainment rates is also the fastest growing. If educational attainment continues to increase at the current slow rates, a large part of our population will not be armed with the skills needed to succeed in the 21st century workforce.

Rising health care costs threaten to monopolize government spending overall as well as Texans' pocketbooks.



- Evidence Based & Data Informed
  - Start with a base of vetted, unbiased, non-partisan data
  - Understand objectively through data where we are today and where we will be absent policy changes
  - Learn and leverage great work that has already been done in Texas and in other states and nations
  - Actionable policy solutions presented in the plan will be evidence based



- Accountability & Flexibility
  - Policies and systems at the state and local levels must align and so that there can be adequate accountability for outcomes and dollars spent as well as enough flexibility for each unique region of Texas to meet their specific needs
  - Each region of our state has unique challenges and opportunities; policies need to allow for flexibility while making clear who is responsible and accountable for what outcomes and provide the systems in which data can be collected so that there can be accountability and a continual improvement loop

- Aligned Incentives
  - Maximize the efficiency of state resources; state and federal resources will always be the largest pots of money – if they are incentivizing ineffective or detrimental activities on the ground, it is almost impossible for a community to reverse that without changing state policy
  - Bring more resources together by expanding collaboration

- Remove Barriers
  - Empower the legislature and agencies to make decisions with data and using evidence based practices
  - Empower communities to come together and be rewarded for solving long term and cross system issues; remove policy and systemic barriers that keep communities from solving the problems they want to solve, the way that is best for them to solve it

# Phases of Work

## ■ Phase I

(Nov. 2016 – Dec. 2017)

- Construct a comprehensive database encompassing all major policy areas for each region of the State and the State as a whole
- Project key indicators to 2036 to understand where we will be absent policy changes

## ■ Phase II

(Sept. 2017 – Dec. 2018)

- Draft “Version 1.0” of the Strategic Plan with assistance of subject matter experts (ex. BCG)
- Solicit feedback from communities and leaders across Texas

## ■ Phase III

(Jan. 2018 - )

- Build wide-spread support for the Strategic Plan and institutionalize an organization to advocate for the implementation of the Strategic Plan through ongoing legislative action, as well as to continue to develop and analyze data sets as they become available over time until 2036
